

AIB - Mission and Objectives

- AIB is established with the aim of contributing to the reduction of mortality and morbidity from vaccine-preventable infections and diseases in European adults.
 - provide evidence-based guidance on fundamental technical and strategic issues
 - monitoring the progress of adult immunization programs at European and (sub)national levels.



AIB – Way of working: 2 meeting per year

Preliminary Meeting Objectives:

- Provide an overview of current vaccine-preventable infections (VPIs) in the adu population (≥18v)
- Discuss the methodology and challenges in computing the health burden of adult VPIs (focus on Europe)
- Understand how the health burden estimates of adult VPIs shape national vaccination policies and practices and inform public health priorities
- Evaluate the current VPIs health burden evidence to provide a convincing case for strengthening adult vaccination in Europe

Intended Impac

Accurate information about the health burden of VPIs in adults is needed for several reasons

- To understand the need and justification for consolidating actual and propose new adult vaccination programmes
- To measure the impact of adult vaccination programs on individual and population health, health systems, economic and social factors
- To collate the rationale to improve prevention / vaccination strategies for adult diseases (e.g. update or revise immunization schedules, implement targeted delivery strategies, etc.)
- To support health policy recommendations and priorities

The purpose of the first AIB technical meeting is to identify and discuss the challenges and opportunities when assessing the health burden of VPIs in European adults.

Target audience (± 60 participants):

The Ault Immunization Board will bring logether European vaccinologists, epidemiologists opinion leaders, policymakers, public health and health care professionals of different specialities, patient groups, professional medical and paramedical organizations. 

An advanced National Immunization Plan



Italy has produced a National Immunization Plan 2017–2019, which was considered one of the most advanced adult vaccination plans in Europe. And the new plan 2023-25 has just been released

A Lifetime Immunization Schedule

Since 2012, the Lifetime Immunization Schedule (Calendario Vaccinale per la Vita) has represented a benchmark for Regional and National Authorities to set up the updated list of vaccines provided actively and free of charge to infants, children, adolescents, adults and the elderly by inclusion in the Triennial National Vaccination Plan (TNVP), and in the Essential Levels of Care (LEA).


On the other hand...

However, national vaccination coverage data by age groups are only available for influenza vaccination, with scarse and non-systematicall collected data on other adult vaccinations.

Also, data on adult immunization by age are not consistently collected.

Moreover, available data show low compliance to vaccination recommendations

The AIB invites local academics, health care professionals, public health representatives and policy makers to present on adult immunization strategies implemented in the country (or group of countries) as well as educational and communicative initiatives aimed at increasing adult vaccine acceptance and coverage rates.

The aim of these meetings is to establish a collaborative network of national experts of different fields, creating a platform for the exchange of knowledge and best practices in adult immunization.



Objectives of this Country Meeting

- Provide an overview of the epidemiology and disease burden of VPI among adults in Italy.
 Explain the functioning of infectious disease surveillance and control programs in Italy
- Provide an overview of the healthcare system in Italy and review how (adult) immunization programs are structured within the Italian health care system. Explain the evaluation and market authorization process of (adult) vaccines in Italy
- Present the Italian Lifetime Immunization Schedule and provide an overview of the new National Immunization Plan (PNPV 2023-25), discuss the decision-making process and criteria according to which vaccines are evaluated and included



Objectives of this Country Meeting

- Discuss the purchase, distribution and financing of adult vaccines
- Explore the organization and delivery of adult vaccination services in different regions of Italy
- Discuss the recording and reporting of vaccination data in Italy, including coverage rate monitoring and the national registry, as well as vaccine impact monitoring and vigilance practices
- Analyze the population's vaccination demand and acceptance, addressing issues such as vaccine
 confidence and compulsory vaccination policies for specific adult population groups
